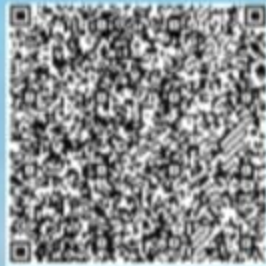

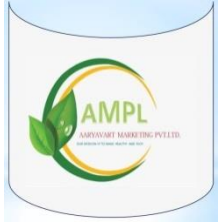

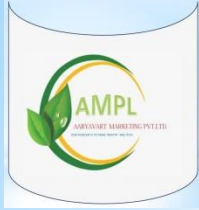


QUALIFIED BLUE STAR
